Discipline Standing Committees Authorized to Elect a Director

- 1. The following standing committees are authorized to elect a Director to the Board of the Association:
 - a. Airsoft;
 - b. Archery;
 - c. Colwood Police Pistol Combat (PPC);
 - d. Malahat Marauders (Black powder);
 - e. Frontier Action Shooters (Cowboy Action);
 - f. Silhouette/Rifle;
 - g. Skeet;
 - h. South Island Action Shooters (IPSC);
 - i. Trap; and
 - j. Victoria Women's Shooting Club.

Criteria

- 2. The **minimum** criteria for a committee/group of members to be considered for approval to elect a director and/or continue to be approved to elect a director, include:
 - a. Conduct a minimum of four club events per year;
 - b. Have a minimum average of eight VFGPA members who participate in organized club events;
 - c. All VGFPA members are eligible to participate in club events and belong to the standing committee:
 - d. Have an elected management committee consisting of a minimum of three people, one of whom represents the standing committee on the Board of Directors.
- 3. A group of members can apply for recognition as a "Discipline Standing Committee" by submitting a written request to the Board of Directors through the Secretary. The request should be signed by three members, list the number of members interested in the discipline, indicate the type of events/activities that are contemplated and outline how their proposed activities would impact existing VFGPA activities.

Election of Director

- 4. An annual meeting must be held before the end of March to elect the new management committee, including the person who will represent the Discipline Standing Committee on the Association Board.
- 5. Only members of the Victoria Fish and Game Protective Association (VFGPA) can vote for the Chair of the Management Committee/Director to represent the Discipline Standing Committee that they are part of. To be eligible to vote, they must have participated in at least one event organized by the relevant Discipline Standing Committee during the previous 12 months.
- A member of the VFGPA may be a member of more than one Discipline Standing Committee and may vote in the election of more than one Management Committee/Discipline Standing Committee Director elections.
- 7. Annual meetings to elect the management committee/director can be held in conjunction with a club match.
- 8. A quorum for the conduct of Discipline Standing Committee elections is the greater of eight members or the average attendance of members at the last three club events.
- All members of the Discipline Standing Committee (as registered with the Membership Chair)
 must receive a minimum of 14 days notice of the annual meeting to elect the management
 committee and director.

General

- 10. A member of the VFGPA can be a member of more than one Discipline Standing Committee.
- 11. The Discipline Standing Committee is responsible for informing the Membership Chair of committee membership.
- 12. A member can request that the Membership Chair add him or her to the membership of a standing committee.
- 13. A Discipline Standing Committee can elect an alternate director to represent them if the primary is not available, but only one may vote (if both are present) at a Director's meeting.
- 14. If a Discipline Standing Committee does not elect a Director to represent them, the Board may appoint someone to represent them.
