General Members Meeting

Officer's Reports

President's Report – Doug Bancroft

- (a) Approx. 1 in 75 residents on Southern Vancouver Island between the ages of 5-75 are now members.
- (b) Over the last 18 months, VFGPA has hosted national level events and, despite significant inflationary pressures, all VFGPA disciplines have survived or thrived, while complying with all government health directives.
- (c) The past 18 months have seen the greatest expenditures for support and maintenance perhaps ever in the same period of time.
- (d) VFGPA under threat by urban encroachment and government regulations.

1st Vice President's Report – Don Senft (on behalf of Glen Shiels)

(a) Commendation to executive members for setting up the AGM in person and via Zoom.

2nd Vice President's Report – Paul MacNeill

(a) Reported on: repairs/renovations to buildings, road repairs, addressing security concerns, development of new SOPs, and bring in of broadband internet.

Treasurer's Report – Dom Piluso

Secretary's Report – Andrew Lemon

(a) Due to COVID-19 and protocols attached there to, there have been no members meetings for this last year, so nothing to report.

Membership Chair's Report – Rick Rutherford

(a) 5439 Members to date. Up 10% over 2020.

Manager/Caretaker's Report – David Michaud

- (a) Have not missed one day of range operations due to closure this year.
- (b) Call for more RSOs and volunteers.

Discipline Director's Reports

Action Shooters Report – Dom Piluso (on behalf on Cheryl Henley)

- (a) 4 COVID compliant matches this year (June through October), averaging 50 competitors per match.
- (b) 2 IPSIC BC matches on Sept 25th and 26th with 121 and 102 competitors respectively.
- (c) 18 people attended SIAS range safety course and a further 5 attend matches after earning their black badge.
- (d) Sport continuing to grow.
- (e) Conducted site cleanup, range maintenance, and installed a new 20 foot storage container.
- (f) Last match of the regular shooting season will be a 3-gun on Oct. 31^{st} .
- (g) Looking for more volunteers.
- (h) With the passing of Waldo/Otis, T-shirts were made to memorialize him.

$Airsoft-Jon \ Bell$

(a) Starting May we have hosted 12 events to date, with a further 4 events to come before the end of the year.

- (b) Average attendance has risen from 50 to 75 per event since ending COVID measures, and we expect to see the numbers to continue to increase back up to the pre-COVID levels of 85-90 participants per event.
- (c) Since COVID, family and female participants have increased.
- (d) Conducted improvements and maintenance to site and structures.
- Archery Ellen Vanderhoek
 - (a) Hosted a number of Scouts and Guides groups.
 - (b) Conducted site cleanup and maintenance.
 - (c) Hosted first 3D shoot with 30 participants. Next 3D shoot scheduled for Dec. 5th.
 - (d) Victoria Bowman Association lost their range and are now restricted to indoor shooting. Hosted them at VFGPA open house to showcase out facilities.

Black Powder – Doug Linton (on behalf of Steve Southin)

- (a) Held 2 rendezvous this year, in addition to monthly shoots.
- (b) Turkey shoot scheduled for the end of Nov.
- (c) Offered 2 courses this year, 10 people per course.

Frontier Shootists – Ashley Harrison

- (a) Site maintenance built up berms between A, B, and C, painted cowboy town.
- (b) Membership growing quickly

Police Pistol Combat (PPC) – Don Senft

- (a) Hosted Canadian Police Combat Association National Championships for the 3rd time. Very successful event. 10 first place finishes from local members and over 40 medals brought home by local members.
- (b) Conducted 8 monthly matches this year.
- (c) Ran an introduction to PPC course to qualify some new members.
- (d) Removed approx. 10 tons of garbage from the RP range
- (e) 2 further monthly events scheduled before the end of the year

Silhouette/rifle – Steve Shulhan

- (a) 3 group training sessions for over 41 participants
- (b) 10 monthly matches with 214 entries
- (c) Several small group training sessions
- (d) Presentations for RSOs
- (e) Orientation session for Victoria Womens' Shooters group
- (f) Site and range cleanup and maintenance
- (g) Have supported the introduction of the Outlaw Rimfire Precision Series (ORPS), and Project Maple seed including two events.
- (h) Plans to expand the frequency of training sessions, further site/range maintenance, and the introduction of air rifle silhouette.

Skeet/Sporting Clay – Paul Hagel

- (a) Upgraded 2 skeet machines.
- (b) Had to turn away shooters due to COVID measures, as too many were coming out to shoot.

Trap – Paul Hagel (on behalf of Mike King)

- (a) Have removed 2 old machines and built new regulation height tops for the new machines.
- (b) Currently have 1 new machine with a 2nd new machine expected to arrive soon.

Victoria Women Shooters – Tina Clark

- (a) After being inactive for over 1 year.
- (b) Events kept to 10 participants to keep within PHOs.
- (c) Made changed to the membership so that it is now a requirement to have passed the Canadian firearms safety course, or have their PAL.
- (d) 40 active members with more enquiries every week.
- (e) Plan to expand their course diversity to include firearms maintenance, outdoor survival, and compass and map navigation.

Initiative Reports

Access – President Doug Bancroft (on behalf of Jim Sprang)

- (a) Since the last AGM the number of Mosaic access cards has grown from 200 to 350 for the two current gates.
- (b) Mosaic is very happy with how our members have conducted themselves on Mosaic lands.
- (c) Negotiations and planning for a new access gate in process.
- (d) VFGPA has also been working with other BCWF member clubs who have been opening up other gates or obtaining access to other parts of Vancouver Island.

Fishing & Big Game – Wayne Zaccarelli

- (a) Largest deer: John Maze 141 lbs.
- (b) Largest blacktail antlers: 74 4/8"
- (c) Spring Bear: 18 7/16th
- (d) Archery Blacktail deer: Gord Adams 141 lbs
- (e) VFGPA conservation donations: Subsidized trapping wolves to increase blacktail deer population, and donated \$1000 to Nature Trust of BC to support salmon habitat.
- (f) Reported on salmon numbers, and salmon camera locations
- (g) Donations to fisheries: \$2000 to World Fisheries Trust, \$5000 to Millstream Fishway Project, \$2000 to Sooke Salmon Enhancement Society, \$2000 to Habitat Acquisition Trust, \$1000 to Public Fishery Alliance.

(h) Halibut quota down this year, so 3 halibut under 90cm per day has been allowed.

Junior Program & Ranger – Megan McCool

- (a) Have been in contact with the North Saanich Rod & Gun Club regarding the use of the 50m range once open for use.
